

The quotation documents will also be available for downloading on the district website <http://www.bhadrak.nic.in> from 10.00 AM of dt.3.2020 to 5.00PM of dt. 12.3.2020.
2. Quotations shall be opened at **12.30 PM** on dated. **17.3.2020** in the office of the Executive Officer, Bhadrak Municipality, Bhadrak in presence of bidders who wish to attend. If the office happens to be closed on the date of opening of bids as specified, the bids will be opened on the next working day at the same time and venue.
3. The quotation documents can be purchased from the Municipal office against a non-refundable fee of Rs.2000.00 towards cost of bid documents in shape of Demand draft/Bankers Cheque issued from any Nationalized / Scheduled Bank payable at Bhadrak in favour of the Executive Officer, Bhadrak Municipality. 6. 8. No bidder will be permitted to furnish the quotation in their own manuscript papers. No letter should accompany the quotation.
9. All corrections made by the bidder including overwriting ,additions, alterations, erasures, obliteration and other discrepancies should be properly attested by the authorized signatory.
10. All quotations received will remain valid for a period of **two years** from the date of issue of acceptance order and can be extended on the same terms, conditions and approved rate or with some additions / deletions / modifications in the terms and conditions, for a further specific period mutually agreed upon by the Bhadrak Municipality and the approved bidder.
11. Every page of the Detailed Quotation Call Notice with required attachments should be signed by the bidder failing, which the quotation will be rejected.
12. The quotation containing extraneous conditions not covered by the quotation call notice are liable for rejection.
13. The Municipality reserves the right of authority to accept any and reject any or all tenders received without assigning any reason whatsoever.
14. The Municipality also reserves the right to choose the offer of any specific firm even if its rates are higher than the corresponding rates of any other firm.
15. The EMD will be retained in the case of successful bidder and will be dealt with as per terms and condition of O.P.W.D. Code. The EMD will be refunded to the unsuccessful bidders on application.
16. No part of the contract shall be sublet without written permission of the Executive Officer or transfer is made by power of attorney authorizing others to receive payment on the bidders' behalf.
17. All equipments as per schedule of works of this quotation should conform to the relevant ISI / manufactures specifications.

18. The participating agencies shall arrange for free inspection of the equipments for first hand assessment regarding its workability etc by the Municipal authorities if they desire so, before acceptance of the offers
19. The equipments supplied / installed shall be covered by the standard warranty clauses of the State Govt. / manufacturing company for the prescribed period subject to **minimum one year** from the date of commissioning of the equipments against manufacturing defect .If any defect noticed during this period, the defective equipment(s) shall be replaced by the agency free of cost. The agency shall maintain the equipments for two years from the date of its commissioning free of cost failing which necessary action as deemed proper shall be taken for blacklisting it. The agency shall repair the equipments within three days soon after receipt of the complain from the Municipality.
20. **Supply order shall be placed phase wise as per actual requirement of the Municipality. On receipt of the supply order, the firm should supply, install and commission it within fifteen days positively.**
21. The bidder should quote the rates both in figures and in words in the appropriate columns for the work items in the schedule of work appended to this notice. If there is a difference between the rate quoted in figures and in words the rate quoted in words shall be taken as correct.
22. The rates quoted should be inclusive of cost, conveyance to the installation site, all taxes & duties of all materials, installation, foundation concreting with Cement Concrete (1:1.5:3), labour & T &P required for the work, fitting, fixing and commissioning etc. No further claim in this regard will be acceptable to Bhadrak Municipality. Deduction of taxes during payment will be made as per rules.
23. In case of any dispute, the decision of the Municipality is final and binding on the firm.
24. All disputes shall be under the jurisdiction of the court at **Bhadrak**.
25. All documents furnished by the bidders are subject to verification from the issuing authority. In case, any manipulation is found during the process or in a later stage, the EMD shall be forfeited besides blacklisting the bidder.
26. This detailed Quotation Call Notice along with the clauses, terms & conditions etc mentioned herein shall form a part of the contract and agreement.
27. The successful bidder is required to execute an Agreement on a non-judicial stamp paper worth Rs.10.00 to be supplied by him, with the Municipality within 7 days from the date of receipt of the letter of acceptance.
28. If the bidder fails to deliver the service as per order within the prescribed time period, then penalty shall be imposed @0.5% of the contract price for each week of delay or part thereof subject to a maximum of 10% of the contract price.
29. 95% payment of the order value shall be made after completion of the work subject to furnishing of bill in duplicate with relevant documents. Balance 5% will be retained as additional security and released after a period of one year subject to adjustment of audit recovery if any as suggested by the audit during the course of its audit. Also, in case of any excess payment made to the firm is detected at any stage or is pointed by audit for recovery, then the same shall be recovered from the firm by way of deduction from his bill/ EMD/security deposit etc.
